CALL FOR RESEARCH ASSISTANT ON DATASET DEVELOPMENT FOR THE PROJECT GENDER-BASED VIOLENCE IN EQUAL TIMES

Objective

The main objective of this project is to compile and organize data on different forms of gender-based violence, integrating socioeconomic, cultural, and political factors that influence its prevalence. The person hired as a research technician will have as their primary responsibility the development of the project's central database, which will include all indicators of gender-based violence and related explanatory variables. Their tasks will involve data collection, cleaning, and the design and construction of a structured database based on this information. Functions

- 1. **Identification of gender-based violence indicators:** Identify and generate data on all relevant indicators of gender-based violence in Spain that are curated, clean, and publicly available.
- 2. **Data collection:** Collect and compile the indicators into a coded database with the highest possible granularity, ensuring its regional and temporal comparability.
- 3. **Database coding:** Design a precise coding system to facilitate classification, querying, and comparative analysis of the data.
- 4. **Data on explanatory factors:** Compile data on explanatory factors such as legislation, support services, social norms, and policies that influence gender-based violence.
- 5. **Public opinion surveys:** Integrate data from surveys on perceptions and attitudes toward gender-based violence to better understand the social context.
- 6. **Continuous updates:** Establish a mechanism for the regular updating of the database with recent information.

Requirements / Desired Profile

Education

Bachelor's or Master's degree in Political Science, Social Sciences, Sociology, Statistics, Computer Science, Engineering, Data Science, or related fields.

Technical Skills (Primary Requirements):

- Experience in the development, management, and analysis of databases, including the use of tools such as Excel, SQL, Microsoft Access, PostgreSQL, or similar.
- Basic knowledge of data architecture and the design of relational and non-relational databases.
- Familiarity with open data management technologies (Open Data).

Secondary Skills:

- Practical knowledge of integrating databases into web platforms and creating applications for interactive data visualization (using frameworks such as Tableau, Power BI, Shiny, or D3.js).
- Experience in programming for data manipulation and analysis: Python (pandas, numpy), R, or similar.
- Knowledge of data protection regulations in Spain and open data standards.

- Interest in the issue of gender-based violence.
- Ability to identify relevant data sources and manage access requests to official data repositories.
- Excellent attention to detail and organizational skills.
- Ability to work independently and as part of a team.
- Availability to attend in-person meetings.

What is Offered

- A temporary six-month part-time contract, with the possibility of extension depending on the project's progress.
- Flexibility to work remotely with periodic in-person meetings if necessary.
- Physical workspace available at UAB if required.
- Gross annual salary of 19,929.05€ part-time (~1.500€/month gross-part time)
- Opportunity to contribute to a high-impact social project, including the creation of the first centralized database with all gender-based violence indicators.

 The possibility of getting involved in the project as much as desired, with the chance to learn about research project implementation and the field of gender-based violence.
